## Kemp Natural Resources Station Alcohol Beverage Policy and User Agreement

Kemp Station recognizes the desire of some users and groups to have alcohol beverages available during meals, events and free time. We strive to accommodate that desire within the constraints of University of Wisconsin-Madison policy on alcohol and the nature of shared living space.

State of Wisconsin laws regarding alcohol are fully enforceable at the Kemp Natural Resources Station, which include but are not limited to:

- 1. It is illegal for anyone under the age of 21 to possess or consume any alcohol beverage (liquor, fermented malt beverage, wine, etc.).
- 2. **Supplying alcoholic beverages to an underage person is illegal.** This includes purchasing alcohol for an underage person at a tavern or liquor store, giving an alcoholic beverage to an underage person, and providing or selling alcohol to an underage person.

In addition to the above state laws, the following alcohol beverage policies are in force at Kemp Station:

## General Policies:

- 1. Users are individually responsible for their behavior and for abiding by the Kemp Natural Resources Station Policy Statement.
- 2. At no time will alcohol consumption by Kemp users be allowed to interfere with the work, comfort, or security of other Kemp users. Concerns should be reported to Kemp personnel immediately. Individual users, guests, and members of Instructional, Outreach and Conference Groups who are under the influence of alcohol or other controlled substances and exhibit disruptive behavior or otherwise interfere with the work, comfort or security of Kemp personnel and other users will be asked to leave the station.
- 3. Any person in possession of alcohol can expect to be asked for identification.
- 4. When approved by authorized Kemp personnel, alcohol may be possessed and consumed only in the Connor Forestry Center; Kitchen & Dining Hall; Lodge Common Area; Mead Dining Room, Deck and Lounge; Pavilion; Cabin; fire ring areas or bedrooms as specifically assigned by Kemp Station personnel. Possession or consumption of alcohol beverages outside these spaces is not permitted.
- 5. Only fermented malt beverages and wine may be possessed and consumed.
- 6. Common sources of alcohol such as kegs, barrels, mixes in large containers, etc. are not permitted.
- 7. Sale of alcohol beverages is prohibited.

## Additional Requirements for Individual Researchers:

Subject to the minimum drinking age, individual researchers may possess and consume alcohol beverages only in authorized locations. (See General Policies #4 above.) Guests of individual researchers may possess and consume alcohol beverages if they have attained the minimum drinking age and comply with the station's General Policies.

## Additional Requirements for Instructional, Outreach & Conference Groups:

Members of Instructional, Outreach and Conference Groups may possess and consume alcohol beverages only when *all members of the group have attained the minimum legal drinking age*. If any member of the group is under the age of 21, alcohol may not be possessed or consumed by any member of the group while at Kemp Station.

I have read, understand and agree to abide by the laws and policies outlined above. I understand that failure to abide by Kemp Station policies may result in removal from and limitation on future access to Kemp Station.
